


9) Describe your firm's corporate citizenship and commitment to the City, participation in charitable programs or scholarships in 2012, and policies with regard to the use of women-owned, minority-owned and disadvanted business enterprises. Does your firm procure goods and services locally?

Stifel has continually operated in the City of Los Angeles since 1955. We currently have two offices located in the City of Los Angeles (Westwood and Downtown) and consistently work to increase our participation in local outreach efforts. Stifel regularly works with MWBE's in our normal course of public finance business as well as through our local procurement of goods and services. In 2011, Stifel established an Academic Outreach Program in partnership with LAUSD's Downtown Business Magnet High School. The program is intended to introduce Los Angeles area minority students to the world of public finance by working with financial models and interacting with the firm's bankers, research department, and sales professionals. It is a 6 week, full time, paid internship program for high school juniors and seniors providing work experience in the field of public finance investment banking. Having recently completed its third graduating class, this internship program has proven to be a very valuable program. We continue to encourage other members of the downtown business community to join with us and expand the opportunities for young people attending the school. We have provided additional details regarding our corporate citizenship and commitment to the City in Appendix A-2.

Stifel takes very seriously our role in being an active member of the communities that we serve. In fact, we encourage all of our employees to be active in their local communities. We participate in a number of charitable endeavors that create social and economic opportunities for the people of Los Angeles. For example, since September of 2011, several members of our downtown Los

Angeles office have participated in the Stair Climb for Los Angeles, raising several thousand dollars for the Ketchum-Downtown YMCA. Our downtown Los Angeles office raises funds and volunteers annually at Downtown's Union Rescue Mission.
