Pursuant to Section 4.6 of the Bond Expenditure Agreement (BEA) executed between the City of Los Angeles (City) and CRA/LA, a Designated Local Authority on January 20, 2015, attached please find the Quarterly Accounting Report No. 30 for the CRA/LA Excess Non-Housing Bond Proceeds (EBP) to include receipt of two (2) Recognized Obligations Payment Schedule (ROPS) payments covering the period from July 1, 2023, to September 30, 2023.

The EBP ending fund balance is \$44,301,543 as of September 30, 2023, highlighted as follows:

OVERVIEW

On January 16, 2015, the City of Los Angeles (City) and CRA/LA, a Designated Local Authority (CRA/LA) entered into a Bond Expenditure Agreement (BEA) (Contract C-125212; Council File 14-1174) whereby certain CRA/LA Excess Non-Housing Bond Proceeds (EBP) would be transferred to the City to carry out activities for which the bonds were sold by the CRA/LA prior to the dissolution of the Community Redevelopment Agency of the City of Los Angeles (Former Agency).

The City received three (3) total CRA/LA EBP disbursements as follows: \$84,071,894.50 on February 2, 2015, a Fiscal Year (FY) 2017-18 ROPS transfer of \$1,900,530.63 on March 28, 2018, and a FY 2019-20 ROPS transfer of \$2,427,927.16 on July 9, 2019. The aggregate EBP of \$88,400,352.29 has been deposited into a Special Fund 57D which is managed by the Economic and Workforce Development Department (EWDD). Special Fund 57D is segregated into various accounts to ensure accurate tracking by project area, bond series, taxable versus tax-exempt EBP allocations, and interest earnings. Section 4.6 of the BEA requires the City to provide a quarterly accounting of its use of the EBP to the CRA/LA. EBP interest earnings as of 9/30/2023 are \$8,531,660.72 bringing the aggregate principal and interest EBP total to \$96,932,013.01.

The BEA allows for 16%, or \$7,690,625, of all taxable EBP/ROPS received plus interest earned to be used over ten (10) years to support program administrative, planning, reporting and staffing costs. However, the City applied (\$277,900) from the administrative pool to cover a project shortfall (C.F. 14-1174-S8), thus reducing the actual available administrative allowance to \$7,412,725. To partially reimburse the administrative pool for this reduction, Council approved the allocation of all available current and future earned interests plus unspent EBP for up to \$277,900 from the East Hollywood/Beverly-Normandie and all Project Areas to the 16% administrative account (C.F. 14-1174-S91). Interest earnings from the East Hollywood/Beverly-Normandie Project Area which may be used for staffing costs total \$83,788, bringing the available administrative allowance to \$7,496,513. Additionally, even though 16% of taxable interest should have been set aside for bond administration, the determination that taxable interest was also eligible for administrative purposes was made after the City had already allocated (\$106,736) of its administrative share to projects, further reducing the actual administrative allowance to \$7,389,777. Through Council action on September 6, 2019 (C. F. 14-1174-S88), interest income has been allocated to staffing administration and 35 projects where applicable. The \$5,796,792 expended through September 30, 2023 represents Office of the City Administrative Officer (CAO) and EWDD's staffing charges and planning activities over 9 fiscal years. There will be only \$1,592,985 remaining in unexpended administrative funds to cover staffing costs through EBP program closeout in 2025.

Based upon the combined (\$384,636) administrative allowance loss due to the above referenced interest forfeiture and C.F. 14-1174-S8 project, the City explored the possibility of accessing all currently available plus future earned and unspent EBP and interest from all project areas to replenish the administrative pool to adequately staff the EBP program. The Office of the City Attorney reviewed this proposition and determined that even though tax-exempt EBP have been refunded and are now taxable EBP, we are only permitted to utilize 16% of the taxable bonds which were taxable when the BEA was executed for our staffing needs.

For period No. 30 ending September 30, 2023, the City expended an aggregate EBP of \$52,630,470 covering the fiscal periods since July 1, 2015. Net of the \$5,796,792 administrative expenditures, the amount incurred by project implementation was \$46,833,678.

As of September 30, 2023, there were 123 total requests consisting of 107 project motions, 7 staffing motions, and 9 receive-reprogram motions for \$107.2 million, or 121%, of the EBP received. However, 9 motions were subsequently rescinded for a combined \$15.3 million resulting in 104 project/staffing motions remaining. In summary, 100% of all EBP and ROPS (net of the 16% taxable EBP and interest administrative allocation) available for eligible projects, programs and activities were accounted for on January 15, 2020 in accordance with the BEA encumbrance deadline.

The entire EBP allocation occurred in all 20 redevelopment project areas within all 13 Council Districts (CDs) for the following eligible activities and CDs:

Public Infrastructure – CDs 1-2-3-4-6-7-8-9-13-14

Community Facilities/Open Space – CDs 1-2-3-4-6-7-8-10-13-14-15

Affordable Housing – CD 1

Business Assistance and Catalytic Commercial Developments – CD 3-7-13-14-15

Administration, Oversight, Planning – CAO, EWDD, CDs 3-7-8-14-15

EBP expenditures are made pursuant to a thorough review of the applicable bond covenants and project area boundaries by the CAO, as well as California Environmental Quality Act (CEQA) environmental review by various City agencies and City Attorneys. Written representation by the CAO that the use of funds is consistent with the redevelopment plan as set forth in the bond documents, are consistent with the original intent for which the bonds were issued, the BEA, applicable provisions of the Community Redevelopment Law and Redevelopment Plans and the Bond Spending Plan (BSP) along with CEQA compliance declaration, and a statement detailing the benefit of the proposed expenditures to the affected taxing entities, are included in all transmittals to the Bond Oversight Committee, City Council and the CRA/LA Boards.

BACKGROUND

The Former Agency was dissolved on February 1, 2012. The CRA/LA was formed to serve as the successor agency to the Former Agency. Prior to its dissolution, the Former Agency and the Community Redevelopment Finance Authority of the Community Redevelopment Agency of the City of Los Angeles (CRFA) had both issued tax-exempt and taxable tax allocation bonds (Bonds).

California Health and Safety Code Section 34191.4(c) allows a successor agency to use proceeds from bonds issued prior to 2011 for purposes for which the bonds were sold. The City and CRA/LA agreed to transfer these proceeds to the City to expend in accordance with the bond documents and government code regulations. The Los Angeles City Council adopted a BSP on October 30, 2014 (Council File 14-1174), followed by execution of a BEA Contract No. C-125212 with the CRA/LA on January 20, 2015. Section 4.6 of the BEA requires the City to provide the CRA/LA with quarterly accounting of its use of EBP. This submittal represents the City's 30th quarterly accounting report.
