REQUEST AUTHORITY TO NEGOTIATE AND EXECUTE A NEW LICENSE AGREEMENT WITH COMMUNITY BUILD, INC. AT 5730-5732 S. CRENSHAW BLVD, LOS ANGELES

The Department of General Services (GSD) requests authority to negotiate and execute a new license agreement with Community Build, Inc. ("CBI"), a 501(c)(3) non-profit organization for approximately 3,334 square feet (sf) of space at 5730-5732 S. Crenshaw Blvd, Los Angeles, California 90043 in Council District 8.

#### **BACKGROUND**

City Council adopted a motion (21-0758) to negotiate a no-cost license with CBI to occupy City owned property at 5730-5732 S Crenshaw. This property includes former Fire Station #54 and an adjacent parking lot which were previously licensed to a different non-profit. CBI will use both parcels to serve the South Los Angeles community by providing pre-employment training, job training, substance abuse counseling, and other supportive services. Food and other resources will be provided to qualified applicants as well.

CBI is a 29-year-old legacy African-American Organization founded after the 1992 civil unrest. Their goals are to develop members of the community by meeting their social, psychological, and financial needs through contract opportunities provided by local, state and federal agencies as well as philanthropic pursuits.

### **TERMS AND CONDITIONS**

The proposed no-fee license term is for one year and will commence on date of attestation by City Clerk. The one-year term is necessary to allow the City to pursue plans to develop





this site as a future Jr. arts center. Authority for this development will be requested in a subsequent report.

CBI will be responsible for utilities and maintenance of the facility, including landscaping. A full set of terms and conditions are included in the attached Term Sheet.

#### **COMMUNITY BENEFIT ANLYSIS**

The Office of the City Administrative Officer (CAO) completed the attached Community Benefit Analysis (CBA) and recommends approval of the proposed terms and conditions of the license. As detailed in the attached CBA, the total community benefit is estimated at \$141,405 annually, which exceeds the rent market value \$70,014 annually for the licensed space by \$71,391.

#### **FISCAL IMPACT**

There is no anticipated impact on the General Fund impact as the license agreement contains no rent.

### **RECOMMENDATION**

That the Los Angeles City Council, subject to the approval of the Mayor, authorize GSD to negotiate and execute a license agreement with Community Build, Inc. for the use of office space at 5730-5732 South Crenshaw Blvd, Los Angeles, CA 90043 under the terms and conditions substantially outlined in this report.

| Background / History:                    | CBI is a 29-year old Legacy African-American Organization founded immediately after the 1992 Civil Unrest, with a goal to develop members of the community by meeting their social, psychological, and financial needs through contract opportunities provided by local, state and federal agencies as well as philanthropic pursuits. |  |  |  |

Highlighted programs and services offered by Community Build Inc. include:

- Gang Reduction and Youth Development (GRYD): As part of GRYD Prevention Program participant, CBI provides violence prevention and intervention services to at-risk, probationary and/or gang involved youth between the ages of 10 and 25. CBI's specific focus is to provide impacted individuals and families with alternatives to become assets to the community, free from current unhealthy behavior patterns. This comprehensive program also provides tutoring, academic counseling, case management, parenting, life skills and ongoing support to address the social determinants that lead to youth falling into crime and gangs. The GRYD program provides real time response to hotspot areas where violence is eminent and the need for suppression through alternatives to law enforcement is necessary. CBI's team of Interventionists are former "Street Culture Involved" individuals known to the specific area they are assigned. CBI provides access to employment and/or vocational training through their referral network of other agencies that have the same and/or similar goals.
- Project Save: The Safe Passage Program assists school-aged students, individuals and families to travel safely within the community, with emphasis on safe travel to school or recreation areas such as parks. The program is composed of CBI staff, local residents, business owners, parent volunteers, schools and local law enforcement, all of whom provide a valuable safety net for students. This program is offered throughout Council Districts 8, 9 and 10 and CBI assists over 30,000 students per year, in nine different schools, with getting to and from school safely. Project Save also works with adults 18-30 and provides the following services:
  - Pre-Employment and Job Training
  - o Employment resources
  - o GED Prep
  - Court ordered Community Service Hours
  - Substance Abuse Counseling
  - Supportive Services
- Community Response System of South Los Angeles: Since the program launch in March 2020, CBI has worked collaboratively with other agencies to distribute over 20 million pounds of food, provided thousands of Chrome Tablet Computers to students, hundreds of hours of online tutoring, hundreds of thousands of PPE's, COVID-19 testing and Vaccinations. CBI is currently seeking Office of Emergency Services (OES) Certification from the State of California to formalize their efforts as a true Disaster Response System that is eligible for FEMA funding and reimbursements.

**Current Services:** 

- Community Health Worker Initiative: Community Health Worker program provides jobs for unemployed/furloughed, reentry and hard to place individuals. Partnering with agencies such as WorkSource LA and Dad's Back Academy, CBI provides temporary employment to the most highneeds areas of the local communities. CBI is also launching a new initiative to hire Community Health Facility Workers. These individuals will be part of our Specialized Sanitation Organization Re-opening Team (S-Sort) and these teams will provide reopening services to essential businesses who have the need for assistance to meet infection control standards for reopening.
- Public Health Institute: CBI has entered into an agreement to utilize a \$350,000 grant with the Public Health Institute to facilitate increased outreach messaging and vaccination efforts. This program will allow CBI to continue to employ, on a temporary basis, community residents to assist at organizing at partner sites, messaging through various media and social media platforms.
- <u>Fiscal Agency Support</u>: CBI currently serves as Fiscal Agent providing financial receiver and management support. Some of these agencies include We Love Leimert Inc., Just Say Hello Campaign, and several other community-based groups. The goal is to increase support of smaller nonprofits in South Los Angeles and utilize this as a revenue stream.
- <u>Senior Services Outreach</u>: CBI has determined that there is a high need to provide additional outreach to senior communities throughout South Los Angeles. CBI is in the planning stages of determining effective relevant and time sensitive programming needed by seniors in the communities.
- Community Safety Initiative: This program was launched in the summer of 2020 with Councilman Harris-Dawson to eliminate/reduce the significant increase in gang related shootings. Safe Passage is provided in twelve different parks throughout the City.
- Homeless Outreach: CBI offers case managed homeless services for individuals enrolled in CBI programs (Project SAVE, GRYD, etc.) through onsite representation from the Los Angeles Homeless Services Authority (LAHSA) and Homeless Outreach Program Integrated Care System (HOPICS). Enrolled individuals receive intensive case management services to support self-sufficiency. A newly formed pilot program, providing initial outreach to homeless encampments that are known to have gang activity, has been launched in conjunction with Council District 8 and 9. The pilot program will assist local law enforcement with reimagining how they provide services in response to these specific groups of individuals.

- <u>Vaccination Support Services</u>: CBI is currently partnering with LYFT to coordinate free rides to various vaccination sites around South Los Angeles. CBI has partnered with a number of network affiliates to increase the number of vaccinated African Americans.
- Heartbeat Campaign: The campaign is a series of commercials that begins with the sound of a heartbeat and proceeds to highlight a specific community challenge that CBI is addressing with its services and programs – keeping the heartbeat of the community going strong. The initial set of commercials will be focused on Vaccine hesitancy and promoting a compelling why.
- Women and Girls Initiative: CBI launched the Women and Girls Initiative to provide outreach and programing and to encourage support of women and girls in the community. The initial programming included free self-defense classes taught at the CBI offices in Leimert Park. CBI is expanding the program to address various social challenges women and girls encounter where they live work and play.
- Social Enterprise Development: CBI has charted the course to expand through launching social enterprises. The initial approach is to partner with organizations that have a need for point of entry into the Los Angeles marketplace.
- HSA Merger and Housing Development: CBI is completing a merger with a local drug and alcohol recovery organization. This will expand CBI's footprint of services and housing development. CBI in partnership with Women Organized for Resources and Knowledge (WORKS) completed the first housing development with 62 units of Permanent Supportive Housing.
