The following technical corrections are being made to Memorandum of Understanding No. 10 for the Professional Medical Services Unit.

SALARY NOTE 8

The second sentence of Salary Note 8 shall be corrected by removing "Appendix H" and replacing with "Appendix C". The new language is displayed in **bold underlined** form as shown below:

The hourly compensation for all employees in the class and pay grades of Relief Nurse, Class Code 2321, is the total compensation for the class. The hourly compensation is specified in **Appendix C**. No bonuses, premiums or other benefits provided by this MOU or the LAAC will apply, except that Relief Nurses who work an 8-hour Day Shift (7:00 a.m. to 3:00 p.m.) or an 8-hour Evening Shift (3:00 p.m. to 11:00 p.m.) on Thanksgiving Day, Christmas Day, New Year's Day, or 4th of July, or an 8-hour Night Shift (11:00 p.m. to 7:00 a.m.) starting the day before Thanksgiving Day, Christmas Day, or New Year's Day, will receive an additional \$100 for each holiday worked.
