Subject: TECHNICAL CORRECTIONS FOR THE 2018-2021 MEMORANDUM OF UNDERSTANDING FOR THE SERVICE AND CRAFTS REPRESENTATION UNIT (MOU 14) (C.F. NO. 19-0845)

The 2018-2021 Memorandum of Understanding (MOU) between the City of Los Angeles and the Service Employees International Union (SEIU), Local 721, for the Service and Crafts Representation Unit (MOU 14) contains the following technical errors that require correction:

1. SALARY NOTE R

Salary Note R shall be corrected by removing the ten dollars (\$10.00) non-pensionable bi-weekly tool allowance and replacing with a fifty dollars (50.00) non-pensionable bi-weekly tool allowance. The new language should reflect the bold underlined information as shown below:

Effective July 7, 2019, employees in the following classes on active payroll status as of July 1, 2019, and each July 1 thereafter for the term of the MOU, shall be provided with a non-pensionable bi-weekly tool allowance in the amount of <u>fifty</u> <u>dollars (\$50.00)</u> to be paid with the employee's paycheck.

All other provisions of Salary Note R remain unchanged.

2. APPENDICES

Theater Technician A, B and C classifications were inadvertently omitted from the Appendices of the MOU. These changes will require a revision to the alphabetical order of the Salary Appendices.
