# REQUEST AUTHORITY TO NEGOTIATE AND EXECUTE A NEW LICENSE AGREEMENT WITH JUDICIAL COUNCIL OF CALIFORNIA FOR SPACE AT THE VAN NUYS COURTHOUSE – 14400 WEST ERWIN STREET, VAN NUYS

The Department of General Services (GSD) requests authority to negotiate and execute a new license agreement with the Judicial Council of California (State) for approximately 1,477 square feet of space at the Van Nuys Courthouse located at 14400 West Erwin Street, Van Nuys, California 91401 for use by the Los Angeles Police Department (LAPD).

# BACKGROUND

On August 1, 2014, the City of Los Angeles executed license agreement C-124360, (CF 11-1519) for the use of several courthouse office spaces including the one at the Van Nuys Courthouse which is used for court-related LAPD business. The lease is currently in a month-to-month holdover status.

In June 2017, the State requested to renew all courthouse licenses under new terms and conditions including paying custodial costs and accurate square footage. The County of Los Angeles provides custodial at the courthouses but the City previously did not pay separate custodial costs. The square footage measurements were resolved in February 2018. However, the custodial costs were never clearly defined in dollar amounts and initial proposals were higher than the proposed rents. In December 2019, the State agreed to limit custodial costs to approximately 25% of license costs with payments to be made directly to the Los Angeles County Superior Court under a separate Memorandum of Understanding (MOU). Authority to enter into this MOU will be requested in a separate report.

# TERMS AND CONDITIONS

The new proposed license will reflect a corrected square footage area which increased from 953 to 1,477 sf and increased monthly rent from \$2,739.87 to \$3,766.35 due to newly negotiated rates. The additional custodial charge of 25% of total rent, or \$941.59 monthly, will result in a total rent amount of \$4,707.94 monthly effective retroactively starting July 1, 2020.

Any increase or decrease in square footage will result in an increase or reduction in rent with a 30-day notice to the landlord based on the current cost per square foot rate.

Complete terms and conditions are included in the attached Term Sheet. The City will enter into a separate MOU agreement with the Los Angeles County Superior Courts to pay custodial costs.

#### MARKET ANALYSIS

Lease comparables for this courthouse are included in the table below. Note: Comparable rent is within one mile of the courthouse evaluated from 2019 to present.

# FISCAL IMPACT

The Leasing Account is funded \$33,782.64 in FY 2020-21. Estimated new costs total \$56,495.25 resulting in a funding shortfall of \$22,712.64.

Rent Increases are due mainly to the new monthly fee for custodial service. The base rent is increasing from \$2,739.87 to \$3,766.35 monthly and the new monthly custodial fee is approximately \$941.59. Total rent is \$4,707.94 compared to previous total rent of \$2,739.87. These new costs are retroactive to July 1, 2020.

Please note that the first year of this new General Fund lease including custodial will cost \$941.59 monthly, or \$11,299.05 annually, with annual increases of 3%. There is an unfunded amount of \$22,712.61 for FY 2020-21 as detailed in the chart below.
