ATP Cycle 7

The California Transportation Commission (CTC) will host a series of kick-off branch workshops from August 2023 to February 2024 to allow local agencies to review and provide input on the guidelines. The CTC anticipates to provide approximately \$555 million in funding for programming in fiscal years 2025-26, 2026-27, 2027-28, and 2028-29.
