HHH Housing Challenge Update

As recommended by the Proposition HHH Citizens Oversight Committee (COC) and Administrative Oversight Committee (AOC), the Mayor and City Council authorized a set-aside of up to \$120 million of Proposition HHH bond authorization to issue the Housing Challenge RFP, with the goal of identifying alternative housing typologies and/or innovative financial models to produce 1,000 new supportive housing units.

Six development teams were awarded a total of \$120 million for the construction of 975 new units of supportive housing (1,001 units inclusive of manager units). These awardees are: Abode Communities/Mercy Housing/LA Family Housing; Brilliant Corners, Bridge Housing, Daylight Community Development, Flyaway Homes and Restore Neighborhoods, LA. On May 12, 2020, the first seven sites under this program were approved by City Council. Pending approval by H+P, the next six sites will be reviewed by Council in August. As summarized in the table below, thirteen of 19 sites have been identified to build 705 of the estimated 975 permanent supportive housing units.

Unforeseen circumstances in Los Angeles have had a dramatic impact on development of these projects. Several developers have elected to pursue Low-Income Housing Tax Credits in their capital stack as a result of the delay of No Place Like Home monies. The Mayor's tolling order suspending development timelines as a result of the Covid pandemic has allowed developers more time to secure sites. Also as a result of the pandemic, there is increased market uncertainty. Still, these awardees continue to move forward.
